BEL AIRE LAND BANK ANNUAL MEETING

I. CALL TO ORDER: Jim Benage called the meeting to order at 6:01 p.m.

II. ROLL CALL:

Present by video conference on Go-To-Meeting were Chairman Jim Benage, Jeff Elshoff, John Welch, Dr. Joel Schroeder, Justin Smith. Diane Wynn joined the meeting later by video conference.

Also present by video conference was Land Bank Treasurer Ty Lasher. Land Bank Attorney Jacqueline Kelly joined the meeting later by video conference.

III. MINUTES

A. Minutes of the March 3, 2020 Bel Aire Land Bank meeting.

MOTION: Mr. Smith moved to approve the March 3, 2020 Bel Aire Land Bank minutes as presented. Dr. Schroeder seconded the motion. *Motion carried 4-0-0* with Mr. Welch abstaining and Ms. Wynn absent from the vote.

IV. RESOLUTIONS AND FINAL ACTIONS

A. Consideration of granting a Utility Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SW ¼ of Section 17, Township 26S and Range 2E.

MOTION: Mr. Schroeder moved to approve granting Utility Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SW ¼ of Section 17, Township 26S and Range 2E and authorize the Land Bank Treasurer to sign. Mr. Smith seconded the motion. *Motion carried 5-0*, with Ms. Wynn absent from the vote.

B. Consideration of granting a Utility Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SE ¼ of Section 17, Township 26S and Range 2E.

MOTION: Mr. Elshoff moved to approve granting Utility Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SE ¼ of Section 17, Township 26S and Range 2E and authorize the Land Bank Treasurer to sign. Mr. Schroeder seconded the motion. *Motion carried 5-0*, with Ms. Wynn absent from the vote.

C. Consideration of granting a Sanitary Sewer Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SE ¼ of Section 17, Township 26S and Range 2E.

MOTION: Mr. Welch moved to approve granting Utility Easement to the City of Bel Aire on a track of land owned by the Bel Aire Land Bank located in the SE ¼ of Section 17, Township 26S and Range 2E and authorize the Land Bank Treasurer to sign. Mr. Smith seconded the motion. *Motion carried 5-0*, with Ms. Wynn absent from the vote.
